Phil Davies was invited to the meeting to represent the football club and reported that the new stand would be placed between the dugouts but will involve some digging out of the area behind. As the League will request a bigger 100 seater stand within the next 2 years, and to reduce the amount of traffic over the pitch, the club is requesting that they put the spoil from the new stand to the left of the dugout, spreading it out over a 30 metre area, compacting and flattening it down where able. This area will then be seeded and landscaped. The spoil can then be used when the stand is extended and they will also add disabled access to the 50 seater stand at that point.
